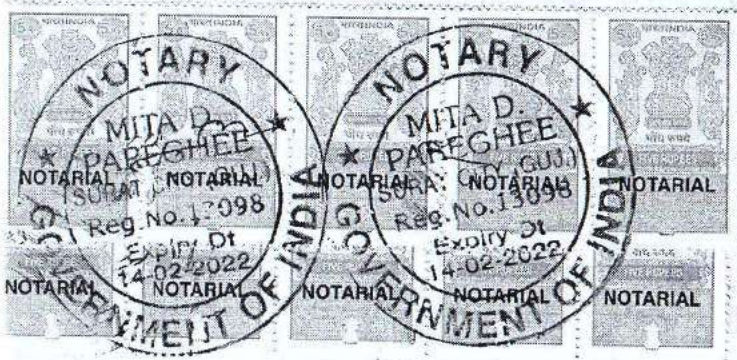

: SCHEDULE - 1 :

Approved Private Primary School has to obey following conditions strictly.
Approval of school can be withdrawn at any time by failing to obeying any conditions from any of these

- [1] This approval has been given subject to bylaw (4) and (7) of amended rule 106(A) of The Mumbai Primary Education Rules-1994.
- [2] Regulation of works of school will be done as per orders/ instructions issued time to time by the Education Committee.
- [3] Rate of salary standards, allowances of educational staff will be kept and pay as time to time approved by the Government.
- [4] Rate of fees required to take from the student by school will be get approved with office and must to collect fees from the student only granted rate and to issue necessary receipt for the same.
- [5] School can not be collect any other type of fees from the students except admission fee, Semester Fee and monthly education fees.
- [6] School will not be managed with object of profit. Statement of School Audit Account will be examined by Education Inspector of School.
- [7] Trust who manage school or managing committee of Society can not make force or to give order for donation or loan gives to trust or society from father or mother of students or guardian, for get admission to students in their school.
- [8] Trust who manage school or managing committee of Board has to open Bank Account in Scheduled Bank and payment of salary of staff should be pay through Cheque System.
- [9] School has to follow prescribed course material and subject schedule and to use textbooks approved or decided time to time by Government. Except approved textbooks should not use other literature as a medium of study material.
- [10] School should not make change governing system of Trust or Board. Change done without prior permission, approval accepting un-authenticallly will liable to cancelled automatically.
- [11] Without prior permission, no any type of change can be done in the place of building of school for which place and building approval given for start school. Cause to such changes issued approval will liable to cancelled.
- [12] School / class have to start in the concern academic year for which approval given. If school will not be started within six months after approval then issued approval will be cancelled automatically.
- [13] In the approved school building should not manage invalid class/ standards.
- [14] By considering size of the educational staff of school that will be sufficient and trained qualified. To appoint only trained teachers having qualification time to time decided by the Government. Recruitment of the teachers subject to provisions of Schedule "F" along with The Mumbai Primary Education Rules-1949.
- [15] Numbers of admission of students per class in school will be kept as per amended rules 106 (A) (7)(3) of The Mumbai Primary Education Rules, 1949.
- [16] Whenever District/ Town Education Committee / District Education Officer or other authorized representatives asked detail for per class schooling, school examination at that time without delay has to provide authorized information.
- [17] Whenever required at that time building of school has to give for use of public examinations or for public interest by surplus by school management.
- [18] With this attached certificate approving as approved private primary school as per provision of The Mumbai Primary Education Act in regarding approval of school.
- [19] At the time of New Recruitment of teachers to appoint surplus trainee teachers in priority basis cause to closing of other private primary school / cause to decrement of class.
- [20] Trust / Board who managing private primary school should not sale its school to other trust / board.
- [21] If approval of your application may be reject previous to this and registered appeal by board- trust in the Government then with it's positive decision approval given by this letter has to make balanced.
- [22] If organization want to file appeal against above stated decision of this office then as per provision of section- 40 A. (8) of the Mumbai Primary Education Act 1947 appeal can be submitted to the Secretary of Appeal, Edu. Div. New Secretariat, Block No.5, 7th Floor, Gandhinagar by applying court fee appeal stamp of Rs.5 within one month from the date of information of decision.
